During the next 10 years MPBOU will turn out to be a major provider of Higher Education in the State of Madhya Pradesh and shall be acclaimed for its contribution to Higher Education in the country. 
## Executive Summary

MPBOU has made an attempt to prepare a vision document for the next decade (2020-2030) in conformity with the vision, mission, values, and objects of the University as mentioned in the MPBOU Act 1991 (MP Act of 1991). The New Education Policy 2020 emphasised on Institutional Development Plan (IDP) for each higher educational institution highlighting strategy for increasing participation of Socially and Economically Disadvantaged Groups (SEDGs), affordable education, inclusive admission policy and curriculum and increasing employability potential of academic programmes. The policy has proposed for a flexible student- centric educational pattern based on both horizontal and vertical mobility of students within and across institutions and programmes having provision for multiple entry, exit and credit transfer.

The major thrust area of the vision document is on access, equity, affordability, quality, innovation, accountability and transparency in administration. University Community Linkages, Technology-Enabled Learning, Skill Development Education, Institutional Collaboration at the National and the International levels, Faculty Development Programmes, Consultancy policy, Placement Policy, Alumni Involvement, Examination Reforms, Total Quality Management and Learners Satisfaction Survey on regular basis are some of the major thrust areas of the Vision Document 2030 of MPBOU.

Resource mobilisation to make the university self-sustainable, networking of Regional Centres and Study Centre for qualitative improvement in student support services, reform in curriculum to make it both job and research oriented, infrastructure development in the permanent campus as envisaged in the Master Plan, scholarship and free education for the disadvantaged groups have been covered in the document.

During the next decade MPBOU shall set a target to establish itself as a premier institution of higher learning in the country with greater emphasis on need- based and skill-based job oriented education creating employment opportunities for the youth of the state. Total quality management will be emphasised on every sphere of activities undertaken by the university. Staff recruitment and training, campus development, online programme delivery, leadership in higher education sphere, positive contribution towards creation of a knowledge society as a major producer of indigenous knowledge and effective participation of students and teachers in socio-economic development of the people and the state are few of our goals set to be

achieved during the next ten years.

We as a team strive for providing quality education and bringing positive difference in the lives of all the stakeholders in the purview of MPBOU. I express my gratitude to the State Government authorities and officials, Governing Bodies of the University, for their support and guidance in achieving the goals of the University.

It is our commitment to achieve newer milestones and create 'Naya Bharat' for our present and future generations. I wish all the success to each and every individual.

To design a technology enabled holistic curriculum for addressing the Global, National and Regional needs through futuristic, socially responsible and learner centric robust curricula.

To offer distinct and divergent academic disciplines and pedagogy for Inculcating Critical Thinking Enhancing communication skills and creativity Boosting conceptualization and problem solving skills Reducing the digital divide and emerging as a digital repository in ODL

Providing seamless technology enabled learning to the students Enhancing the employability skills of the learners.

The MPBOU has been developing the credit based Self-Learning Materials (SLMs) for all the Programmes since its operation in 2003. It is the need of the hour to strengthen its Programmes on par with the conventional Universities for encouraging mobility during the course of study. Thus, the Choice Based Credit System (CBCS) will be implemented in all the UG and PG Programmes to provide plenty of scope to opt for multiple subjects with flexibilities in a Programme that will offer a wide range of options/add-ons to ensure intellectual development, in addition to a learner's core subject.

According to the Madhya Pradesh Skill Development Mission Skill Gap Assessment Study and Action Plan for Madhya Pradesh" (2022), the median age of Madhya Pradesh will increase to 37 years by 2026. Hence, the State needs to invest in Skill Development immediately at multi-levels to reap benefits of demographic dividend. Further, the Report alarmed that during 2015-16, the youth unemployment rate in the State was 14% (age between 18 and 29) that was marginally higher than the national average 13%. However, the FICCI in its "Envisioning India 2030" predicts that India's working age population will increase by around 12 million per year until 2030.

With an aim to enhance the skill sets of the unemployed youths in the State and to make them qualified, the University conducts 26 Vocational Diploma Programmes and Certificate Programmes in skill development in diverse sectors through the Community Colleges. The Curricula of these Programmes shall be revised in compliance with the National Skill Development Corporation (NSDC) and the National Vocational Education Qualifications Framework (NVEQ) for fulfilling the nation's demands in terms of increasing the skilled youth. It is proposed that the University shall introduce at least 100 Skilling Programmes through Constituent Community Colleges and Community Colleges by 2030.

In Chapter-II, the Draft National Education Policy, 2022 (NEP), illustrates the importance of the liberal arts education that has indeed become extremely important in the modern day employment landscape of the 21st century, and liberal arts education of this kind is already being extensively implemented today (e.g. in the United States in Ivy League schools) with great success. The NEP also advises that the Universities should offer the liberal arts education in the coming days.

In order to implement the suggestion of the NEP, the University shall propose to introduce four-year Bachelor of Arts (Liberal Arts) Honors Degree and Bachelor of Science (Liberal Arts) Honours Degree through distance mode. These Programmes shall offer holistic learning environment to the learners for their personal growth through research and analytical thinking to develop talents and values for employability, leadership and social consciousness and harmonious global environment.

As the flexible learning is synonymous with the Open and Distance Learning, the University unfolds the provisions for multiple entries in the existing UG and PG Programmes like MCA (Master of Computer Applications), M.Sc (Counselling and Psychotherapy) and BCA (Bachelor of Computer Applications) and for multiple exits in B.Sc (Apparel and Fashion Design) Programmes. In want of modularity in more Programmes, the University shall propose to introduce at least 10 Programmes, including UG, PG, Diploma and Certificate Programmes for enabling multiple points to enter and exit.

The 4th Sustainable Development Goal of the United Nations aims to “ensure inclusive and equitable quality education and promote Lifelong Learning Opportunities for all” (UN,2016).

Lifelong learning is a mission of the University to reach rural communities for improving their livelihoods. In this regard, an exclusive School of Continuing Education functions in the

University for offering skill development Programmes.

In future, the University shall establish lifelong learning section as part of all the Schools/Departments of the University for offering need based short-term programmes for expansion of lifelong learning with open enrolment.

In the present scenario, collaborative method is encouraged among the Higher Educational Institutions for sharing learning resources such as research, faculty and learner exchange. This method provides a wide range of opportunities to the learners. In this regard, the University shall initiate steps to sign the Memorandum of Understandings with the other Open Universities and the Dual Mode Universities for adapting/adopting their Programmes in the MPBOU.

Expansion of tertiary education is being undertaken with the support of the Information and Communication Technology (ICT). The University Grants Commission encourages the Online Programmes through MOOCS/ SWAYAM.

The University shall initiate the Hybrid Learning Model (where part of the program is taught online and part in person) to attract the adult and working professionals who are aspiring for additional credentials. The model provides them with the flexibility to access course material as their schedule permits.

In 2016, the University Grants Commission had permitted the Credit transfer for Online Learning Courses through SWAYAM in all the Universities' Programmes. In view of this, the MPBOU shall propose to implement the Regulations for providing multiple opportunities for the learners to choose their interested Courses through SWAYAM that will be considered for credit transfer.

The Skill Development Programmes planned in the MPBOU to cater to the needs of those who aspire for enriching their skills, MPBOU has Community Colleges across the State. These Community Colleges have industry tie-ups to offer hands on experience to the learners.

The FICCI insists on the effective industry and academia engagement to increase employability of trainees. It also expects that apprenticeship should be integrated across vocational and higher education.

According to the "Skill Gap Assessment and Action Plan for Madhya Pradesh", the Government of Madhya Pradesh through the Madhya Pradesh Global Investors Meet identified

eight sectors for greater focus as listed below:

- Apparel & Textile Manufacturing
- Engineering, Automotive & Metals
- Agriculture & Food Processing
- Building & Infrastructure
- Tourism & Hospitality
- IT / ITES

With a view to fulfilling the demands for skilled manpower in India, the University shall propose to launch specialized courses to cater to the needs of the above sectors.

The relevance of the curriculum to the present context is ascertained and the curricula are revised from time to time. In MPBOU, the curricula are revised with a view to including the new emergence of the subject periodically. However, the role of stakeholders in the revision is well recorded now. In this context, the University has developed feedback mechanism for the teachers, subject experts, academic counselors, learners, alumni and employers separately for collecting their opinions for consideration while revising the curricula. Moreover, the University shall propose to revise the curricula at least once in three years. Notwithstanding, the final Unit will be allotted as dynamic unit for incorporating new trends. The final Unit will be revised as and when required.

According to the MPBOU Act, the University is empowered to coordinate and determine the standards in the Open and Distance Education system in the State. In 1991, the Government of Madhya Pradesh mandated the University to ascertain Common Syllabus for the Distance Education in the State. In this regard, the Curriculum Development Cell, MPBOU held a meeting with the representatives of the State Universities for possible implementation.

In the wake of emerging demands for quality distance education and online education for increasing the Gross Enrolment Ratio (GER) in Higher Education in Madhya Pradesh, it is warranted that the sustainable quality in Distance Education should be ensured on par with On Campus Education. In view of this, the MPBOU shall take effective measures for introducing Uniform Syllabus in Distance Education in the State in consonance with other Universities.


