### NOTIFICATION


Madhya Pradesh Bhoj Vishwavidyalaya, Bhopal established by the Madhya Pradesh State, came into existence w.e.f 1<sup>st</sup> October, 1992 by an Act of State Legislature vide notification No. 12534-21-A (PRA) dated 17<sup>th</sup> September, 1991 which is already included in the list of Universities maintained by the UGC under Section 2 (f) of the UGC Act, 1956 vide notification No. F. 9-6/1994 (CPP) dated 14.12.1994 is now declared eligible to receive central financial assistance in terms of Rules framed under Section 12 (B) of the UGC Act, 1956. The University shall receive developmental assistance from Distance Education Council, IGNOU, New Delhi.

The name of Madhya Pradesh Bhoj Vishwavidyalaya, Bhopal has been changed as "Madhya Pradesh Bhoj Open University, Bhopal vide Madhya Pradesh State No. 40 of 1997 and its office has been shifted to ITI Gas Rahat Bhawan, Govindpura, Bhopal.
