Revised Order

Whereas, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993(73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education has notified the Regulations, 2014 on 01.12.2014.

2. And whereas, the **MADHYA PRADESH BHOJ(OPEN) UNIVERSITY, RAJA BHOJ MARG, KOLAR ROAD, BHOPAL -462016, MADHYA PRADESH** by affidavit date. 16.02.2015 has consented to come under new Regulations and sought for two basic units in **B.Ed (Distance Education)**, which require additional facilities.

3. And whereas, it has been decided to permit the institution to have two basic units of 500 students each. One study centre shall not enroll more than 50 student in a given session. Subject to the institution fulfilling following conditions namely:-

I. The institution shall create additional facilities that include (a) additional built-up area, (b) additional infrastructure, (c) additional funds, (d) additional staff as per Regulations, 2014 and inform Regional Committees with required documents by October 31, 2015.

II. The applicant-institution for additional unit will be required to submit the required documents such as land documents, Encumbrance Certificate (EC), Land Use Certificate (LUC), Building Plan (BP) and the Approved Staff List in the specified proforma available on the website to the Regional Committee in proof of having provided additional facilities before October 31, 2015. Building Completion Certificate (BCC) may be given along with other documents if available, otherwise it can also be given to the Visiting team at the time of inspection.

III. The Regional Committees shall arrange for verification of documents, inspection of these premises and check adherence to these conditions by 20 Feb, 2016. If it is found by the Regional Committee that the institution fails to comply with these requirements, the institutions shall not be permitted to admit students for the academic year 2016-2017.

IV. In case any existing institution's matter is sub-judice under court direction/SCN under section 17 of the NCTE Act/Complaint etc., the institution shall be required to submit a copy of the Hon'ble Court order/reply to SCN/complaint/already submitted alongwith the documents, if any together the documents referred above. In case the institution's request for shifting of premises is pending, such institutions shall be required to submit the requisite documents as per provisions of the NCTE Regulations, 2014 with a copy of the order/NOC of the affiliating body/State Govt. and such other documents as indicated in the revised format recognition order. The final decision shall be subject to the directions given by the Hon'ble Court in the Writ Petition/case decided by the Western Regional Committee in respect of Section 17/complaint cases etc.

4. Now therefore, in the light of the above and in accordance with the **NCTE Regulations, 2014, the Western Regional Committee (NCTE) hereby issues the revised recognition order to MADHYA PRADESH BHOJ(OPEN) UNIVERSITY, RAJA BHOJ MARG, KOLAR ROAD, BHOPAL -462016, MADHYA PRADESH for conducting B.Ed(Distance Education) programme of two years duration with an annual intake of 1000 students (two basic units of 500 students each) from the academic session 2015-16 subject to fulfillment of the conditions mentioned herein before 31.10.2015. One study centre shall not enroll more than 50 student in a given session.**

5. Further, the recognition is subject to fulfillment of other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/Body, the State Government etc, as applicable. The affiliating body (University/State Govt.) shall also be required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

6. The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with the statement of annual accounts duly audited by a chartered Accountant.
7. The institutions shall maintain & update its web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-
 - a) Sanctioned programmes along with annual intake in the institution:
 - b) Name of faculty and staff in full as mentioned in school certificate along with their qualifications, scale of pay and photograph.
 - c) Name of faculty members who left or joined during the last, quarter:
 - d) Names of Students admitted during the current session along with qualification, Percentage of marks in the qualifying examination and in the entrance test, if any, date of admission, etc.;
 - e) Fee charged from students;
 - f) Available infrastructural facilities;
 - g) Facilities added during the last quarter;
 - h) Number of books in the library, journals subscribed to and additions, if any, in the last quarter;
 - i) The affidavit with enclosure submitted along with application.
 - j) The institution shall be free to post additional relevant information. If it so desires.
 - k) Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.

If institution contravenes any of the above conditions or the provision of the NCTE Act, Rules, Regulations and orders made and issued there under, the institution will render itself liable to adverse action including withdrawal of recognition by the Regional Committee under the provisions of Section 17(1) of the NCTE Act 1993.

8. **Recognition order Dated 28.08.2002, 04.02.2008 be treated as cancelled from the date of issue of this revised order.**

MEMORANDUM OF UNDERSTANDING (MOU) FOR PROMOTION
OF EDUCATION FOR THE EMPOWERMENT OF PERSONS WITH
DISABILITIES

The Memorandum of Understanding (MOU) between Madhya Pradesh Bhoj (Open) University (hereinafter referred as "MPBOU, Bhopal" Madhya Pradesh) having its office at Raja Bhoj Marg (Kolar Road), Bhopal - 462016 and the Rehabilitation Council of India (hereinafter referred as "RCI"), a Statutory Body under Ministry of Social Justice and Empowerment, DEPWD, Govt. of India, having its office at B-22, Qutub Institutional Area, New Delhi - 110016 was Signed on 18.01.2000 for collaboration in promoting education through distance mode for the empowerment of person with disabilities for a period of 05 years upto 18-01-2005.

In pursuance of the above MOU, Special Education courses namely B.Ed. Special Education, through Open & Distance Learning mode (B.Ed. Spl. Edn.-ODL) in the area of Intellectual and Developmental Disabilities, Visual Impairment, Hearing Impairment & Learning Disabilities were successfully implemented with an encouraging acceptability and increasing demand.

The above said MOU was renewed on 31.01.2004 for another period of five years upto 31.01.2009 & further renewed up 09.11.2014 and further renewed up 31-10-2019 to conduct the special education courses as per the provisions of MOU.

The present MOU is an extension of the MOU signed between MPBOU, Bhopal Madhya Pradesh and RCI, New Delhi on 31.10.2014 for collaboration in promoting education for the empowerment of persons with disabilities and is governed by the following provisions.

1. The MPBOU Bhopal (M.P.) will collaborate with RCI in designing programme and development of multimedia for Special Education courses through Open & Distance Learning (ODL) and will facilitate delivery and certification of such courses.

2. RCI recognizes MPBOU, Bhopal, M.P. as State Open University equipped to undertake Special Education courses through Open & Distance Learning (ODL) in Hindi & English medium RCI will also extend technical expertise to MPBOU Bhopal, M.P. and its Study Centers as and when required.

3. MPBOU, Bhopal, M.P. as per MOU will conduct the following courses through Open & Distance Learning (ODL) mode in the State of Madhya Pradesh in Hindi & English medium till the validity of MOU. Course wise allocations of seats to University & its Study Centers are as under:-

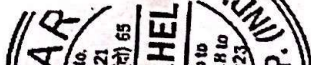
4. Training programme(s) through ODL mode for B.Ed.Spl.Ed. shall be conducted as per the prescribed norms and regulations of RCI. Self Learning Material (SLM) shall be developed by the MPBOU, Bhopal, M.P. in light of the revised syllabus.

5. For aforesaid training programmes, the faculty and infrastructural facilities at the University academic contents eligibility conditions and process of evaluation etc. shall be as prescribed by the RCI from time to time.

6. All the Special Education training programmes to be conducted in future need to be planned on Self-Financing and Self-Sustaining Scheme with generation of funds through course fees and other charges to meet the running cost of the course.
7. The amount of the Programme Fee and other charges is to be decided jointly by RCI & MPBOU, Bhopal, M.P. to meet the financial implications for self-financing. No other fee or any other amount shall be charged by MPBOU, Bhopal, M.P. from the students.
8. On the basis of the criteria mentioned at Clause (5), course fees will be shared by the MPBOU, Bhopal, RCI and the Study Centre(s) on PRORATA basis as per the norms fixed for each course as per need. The norm of sharing of course fees and other charges shall be fixed on a long-term perspective as per the following proportion.
 - (a) MPBOU, Bhopal, M.P. 50% of the total fee and charges collected in r/o special education courses and other courses as mentioned at Clause(3).
 - (b) Study Centre: 40% of the total fee and charges collected in r/o special education courses and other courses as mentioned at Clause (3).
 - (c) RCI: 10% of the total fee and charges collected in r/o special education courses and other courses as mentioned at Clause (3).
9. Study Material in respect of aforesaid courses will be provided by MPBOU, Bhopal, M.P. to Study Centres and students as per the requirement.
10. Training institutions already running the B.Ed.Spl.Ed. training programme approved by the Council in the State of Madhya Pradesh shall only be considered as a Study Centre(s), subject to fulfilment of the prescribed eligibility conditions to become study centres as mentioned in the revised B.Ed. Spl.Ed.-ODL norms, 2021
11. MPBOU, Bhopal, M.P. will provide the list of prospective Study Centre(s) to RCI for issuance of NOC to act as a Study Centre under MPBOU, Bhopal, M.P.
12. In case approval is not further extended to any training institutions for conducting B.Ed. Spl.Ed. programme through face-to-face mode, the eligibility to become Study Centres will automatically stands cancelled. However, the students already enrolled in the study centre concerned will be allowed to continue the course within the time frame as stipulated under Clause-3.
13. MPBOU, Bhopal, M.P. and RCI will jointly decide the norms in respect of the honorarium to the faculty and detailed process of admission, examination and evaluation etc.

14. MPBOU, Bhopal, M.P. shall conduct the training programmes as per the prescribed syllabus of RCI and shall also conduct examination and award Marksheet and degree to the students. However, for registration in CRR of RCI, Authentication Certificate shall be issued by the concerned study centre(s) from where the candidate has completed the course.

15. Any dispute between MPBOU, Bhopal, M.P. and the concerned study centre shall be resolved by them only. RCI will not be responsible for any such dispute. There will be an Apex Advisory Committee which will normally meet twice a year to oversee the implementation of the MoU. The composition of AAC shall be as under.

17. The present MoU shall be valid for a period of 5 years w.e.f. 30.10.2019 and may be renewed from time to time at 5 (five) years of interval on mutual agreement. However, it may also be terminated earlier by either party giving advance notice of one academic session.

18. Both the parties hereto agree that any dispute arising out of this MOU shall be settled mutually through discussions and that in the event of their failure to settle the dispute; the matter shall be referred to Sole Arbitrator appointed with the consent of both the parties in New Delhi.
