About CIQA

Madhya Pradesh Bhoj (Open) University, Bhopal, established the Centre for Internal Quality Assurance (CIQA) with the primary focus to promote awareness for the quality of academic and administrative areas and work out the procedural details to comply with all seven criteria of NAAC. The CIQA is a coordinating unit delegated to ensure total quality by best practices and intervention strategies leading the university to academic excellence. CIQA, as per its mandate, is working to aligning the university towards NAAC preparedness.

The following functions are being performed by the CIQA consultants –

- To act as a coordinating unit for assessment and accreditation from a designated accreditation agency.
- To identify the critical areas in which the university should maintain quality.
- To receive/collect information/data from all the University Departments, Regional Centres, and Study Centres on various procedural requirements, parameters, and/or regulatory norms prescribed by the regulatory/accreditation bodies.
- To undertake self-evaluative and reflective exercises for continual improvement in all the systems and processes of the university.
- To identify the gaps in the existing services offered by the university and suggest measures for qualitative improvements.
- To develop quality benchmarks/parameters for various academic and administrative activities of the university.
- To develop and exercise mechanisms for interaction and obtaining feedback from various Schools/Departments/Regional Centres/Study Centres of the university and students, employees, and other stakeholders as input for quality improvement.
- To facilitate the implementation of recommendations of periodic reviews.
- Prepare *Program Project Report* (PPR) for each program, get the PPR approved, put in place monitoring mechanism to ensure implementation of PPR.
- To develop and/or review university policies and recommend the corrective actions.
- To organize and/or help the university departments to organize workshops/seminars/symposiums/awareness programs on quality related themes, ensure participation of all stakeholders, and disseminate the reports of such activities among all the stakeholders.
- To assist in the development, revision and improvement of various policy documents of the university and UTDs.
- Supervise the development of SLM and suggest effective corrective measures, if any.
- To ensure participation of stakeholders (Students, Employees, Societies, and others) in quality improvement processes.
- To assist system based research towards creating a learner-centric environment.

4. Conferences

It is one of significant contributions of CIQA to the MPBOU, Bhopal. For the development and prior approval of Vision, Mission, and Values, a standard process has been followed. Finally, new Vision, Mission, and Values have been approved in the 92nd meeting of the Board of Management of the university (dated 12/09/2022).

8. Best Practice Document

In response to email subjected Advisory to Higher Educational Institutions running Open and Distance Learning Programs on March 3, 2022 at 4:45 from UGC (DEB), through following a prior procedure and a series of systematic discussions with different stakeholders, best practices of the university have been identified and documented.
