Annual Maintenance Contract for elevator

Nagar, Bhopal, Pin 462011 being party competent as qualified for doing required job hereafter called "T K Elevator" and Registrar, Madhya Pradesh Bhoj (Open) University, Bhopal.

Madhya Pradesh Bhoj (Open) University is required a Comprehensive maintenance service for the same and where as M/s T K Elevator (India) Pvt. Ltd., Bhopal has agreed to provide the said maintenance services covered by this agreement Now, it is hereby mutually agreed as upon.-

A. Preventive maintenance and annual services:-

M/s T K Elevator (India) Pvt. Ltd. shall provide Comprehensive maintenance of T K make VVVF control lift including replacement of spares, oil, and greasing, rewinding of motors, repairing of control panel, COP, landing panels, over speed safety required. Parts include VVF inverter, hoist motor, ARD including Battery, Car announcement system, guide rail shoes, control cables, pulley, brake system, gear system, wire rope and related accessories for interlocking other facilities given in the lift and outside lift operating switches. The periodical examination & servicing of safety device, Governor & wire rope replacement shall be done with submission of test reports etc. comprehensive maintenance including 12 times a year on monthly basis, maintaining relevant safety standard including full load testing. M/s T K Elevator shall also assist during annual government agency inspection.

B. Standard Mentions:-

M/s T K Elevator shall replace or repair, free of charge, the following range of components for reason related to normal wear and tear, Cover-age shall be inclusive of repair or replacement of machines, generators, ropes, inverter systems and controller parts are inclusive of printed circuit boards. Sub component inclusive of belts, roller, gear, bearing, solenoids, coils, chock brake shoes, liners, term lightning, nuisance calls, act of civil or military authorities, strikes, lockouts, for contacts, contractors, relays, coils, push buttons, door operator VVVF drive, card door safety device limit switches, governor, hoist way door locks, indicators and other minor mechanical parts shall be included except as exclude. Components will be furnished by the M/s T K Elevator on exchange basis under which the replaced components become the property of the M/s T K Elevator.

M/s T K Elevator shall not be obligated to service or make renewals of repairs without additional charges upon the equipment by reason misuse of the equipment, another's negligence, loss of power, blown fuse (s), tripped stop switches, theft, vandalism, explosion, fire, power failure, water damage, se majeure, or any other reason or cause beyond our control. In the event any component of the elevator become obsolete, outmoded, or is no longer manufactured by the original manufacturer or available in the open market or in T K Elevator opinion cannot be repaired, replacement of such upgraded components shall be at Purchaser's expenses.

Note: - If in case of replacing new spare part, a certificate from vender is required, the certificate must be guanine and ISI standard.

C. Price:-

The price for services during period of contract shall be Rs. 136380/- (One Lakh Thirty Six Thousand Three Hundred Eighty Only) +18% GST. No price variation expect statuary and government levies shall be allowed Payment of any type of Labour/ Transport whatsoever shall not be made extra in any case.

D. Security Deposit:-

M/s T K Elevator has deposited a security of Rs. 5000/- which will be refunded within a month after successful; completion of all contractual formalities.

E. Payments:-

The payment against the contract shall be made quarterly End of submission of invoice to Office in Charge generally within 15 days or turn as per queue, whichever is later by the Registrar, Madhya Pradesh Bhoj (Open) University, Bhopal after completion of maintenance for the half yearly & subject to completion of all contractual formalities.

F. Penalty:-

- i. M/s T K Elevator (India) Pvt. Limited shall provide the services on scheduled time or on call (if required by the Registrar, M.P. Bhoj University) in case delay in service beyond 24 hours (Where no spares required) penalty @ Rs. 300/- Per day subject to maximum of 1.5% of contract value may be imposed.
- ii. If any of the service/spare if found to unsatisfactory or workmanship found to develop defects during contract period, it will have to replace/rectified by M/s T K Elevator free of all charge positively within reasonable time from the date of acknowledgment of intimation.
- iii. Delay in service is permissible 24 hours in case of no spares. The vendor will be bounded to replace the part within 48 hours in any case.

G. Term:-

This agreement for outline equipment is effective for one (1) year (s) stating from 15/10/2022 to 14/10/2023, Non- cancelable unless either party timely serves written notice upon the other party of its intention to cancel at least ninety (90) days before the end of the initials contract period or any subsequent renewal. Notice shall be sent by certified mail, return receipt requested.

H. Extension of contract:-

Registrar Madhya Pradesh Bhoj (Open) University, Bhopal reserves the right to extend contract for one year on the same terms and condition. The price stated that in this agreement may be revised for the second year to accommodate increase in overall service cost. Such revision shall be based on 'IEEMA' Basic price variation clause for Maintenance Contracts for elevator/Escalators plus 5%





over and above the adjusted percentage. For this, M/s T K Elevator will be required to submit an offer adjusting increase in service cost based on IEEMA basic price variable clause as mentioned above at least 45 days before completion of term.

I. Assignment:-

M/s T K Elevator shall not assign this agreement or any part to any third party thereof any benefit there under without the written consent of Registrar, M.P. Bhoj (Open) University.

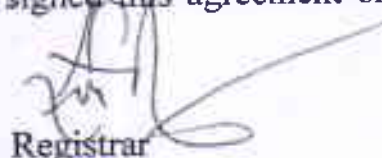
J. Dispute Resolution:-
