- Up to 70 years.


### TENURE PERIOD OF APPOINTMENT AND DURATION OF THE CHAIR:



- Inclusion of IKS as a course at undergraduate/ Post graduate level, which shall earn credits for being included in overall aggregation of assessment and marks of the student for the said course, which the student may be undergoing in the University/ College/ Institutions of Higher Learning IKS
- Inclusion of post-graduate degree/ diploma courses on the field of IKS.
- Inclusion of exclusive curricula on IKS for doctoral and post-doctoral studies.
- Inclusion of certificate courses/ distance learning courses/ online courses on IKS.
- Provision of full time/ part-time scholarships and fellowships for conducting research in legal, economic, socio-legal, social, technological, entrepreneurial aspects of new and emerging IKS areas (national and international) of interests.
- Setting up of a repository for IKS related information and case studies at the university/ institution both in physical and electronic form.

The Institute may restrict the number of applicants to be called for interview to a reasonable limit, on the basis of qualification and experience higher than that of the minimum prescribed in the advertisement. Therefore, applicants should furnish details of all the qualifications and experience possessed in the relevant field, over and above (if any) the minimum qualification prescribed along with documentary evidence.
