ADDENDUM OF STATUTE No. 1-A

APPOINTMENT OF KULPATI

1. The Kulpati shall be appointed by the Kuladhipati from a panel of not less than three persons recommended by a committee constituted under clause (2) or clause (6).

Provided that if the person or persons approved by the Kuladhipati out of those recommended by the committee are not willing to accept the appointment, the Kuladhipati may call fresh recommendations from such committee.

- 2. The Kuladhipati shall appoint a committee consisting of the following persons, namely:
 - i) One person nominated by the Kuladhipati
 - ii) One person nominated by the Chairman, Distance Education Council
 - iii) One person elected by the Board of Management

The Kuladhipati shall appoint one of the Three persons to be the Chairman of the committee.

- 3. For constituting the committee under clause (2), the Kuladhipati shall, six months before the expiry of the term of the Kulpati, call upon the Board of Management and Chairman, Distance Education Council to choose their nominees and if any or both of them fail to do so within one month of the receipt of the Kuladhipati's communication in this regard, the Kuladhipati may further nominate any one or all the persons as the case may be, and the person or persons so nominated shall be deemed to be the person nominated by the Board of Management or the Chairman, Distance Education Council, as the case may be.
- 4. No person who is connected with the University/ Regional Centre or any College associated with the University, shall be elected or nominated on the committee under clause (2).
- 5. The committee shall submit the panel within six weeks from the date of its constitution or such further time not exceeding four weeks as may be extended by the Kuladhipati.
- 6. If for any reasons the committee constituted under clause (2) fails to submit the panel within the period specified in clause (5), the Kuladhipati shall constitute another committee consisting of four persons, not connected with the University/Regional Centre or any college associated with the University, one of whom shall be designated as the Chairman. The committee so constituted shall submit a panel of three persons within a

period of six weeks or such shorter period as may be specified, from the date of its constitution.

- 7. If the committee constituted under clause (6) fails to submit the panel within the period specified therein the Kuladhipati may appoint any person whom he deems fit to be the Kulpati.
- 8. The Kulpati shall hold office for a term of four years and shall not be eligible for appointment for more than two terms.

Provided that notwithstanding the expiry of his term he shall continue to hold office until his successor is appointed and enters upon his office but this period shall not in any case exceed **six months**.

Provided that he shall cease to hold office on attaining the age of 65 years.

- 9. The Kulpati shall be a whole-time salaried officer of the University and his emoluments and other terms and conditions of service shall be governed by the Statute 1-A (the existing statute No.1 will be renumbered as 1-A).
- 10. If at any time upon representation made or otherwise and after making such enquiries as may be deemed necessary, it appears to the Kuladhipati, that the Kulpati:-
 - (i) Has made default in performing any duty imposed on him, by or under the Act; or
 - (ii) Has acted in a manner prejudicial to the interests of the University; or
 - (iii) Is incapable of managing the affairs of the University the Kuladhipati may, notwithstanding the fact that the terms of office of the Kulpati has not expired, by an order in writing stating the reasons therein, require the Kulpati to relinquish his office as from such date as may be specified in the order.
- 10.1 No order under clause (10) shall be passed unless the particulars of the grounds on which such action is proposed to be taken are communicated to the Kulpati and he is given a reasonable opportunity of showing cause against the proposed order.
- 10.2 As from the date specified in the order under clause (10), the Kulpati shall be deemed to have relinquished the office and the office of the Kulpati shall fall vacant.
- 11. In the event of the occurrence of any vacancy including temporary vacancy in the office of the Kulpati by reason of his death, resignation, leave, illness or otherwise, a Director or Registrar of University or any officer of the State Govt. nominated by the Kuladhipati for that purpose shall act as the Kulpati until the date on which the Kulpati is appointed under clause (1) or clause (7) to fill such vacancy enters upon his office;

Provided that the arrangement contemplated in this clause shall not continue for a period of more than six months.

Note - The Provision regarding appointment, removal and terms and conditions of service of Kulpati shall be so far as may be on the same lines as that provided in M.P. Vishwavidyalaya Adhiniyam, 1973 as amended from time to time.

मध्यप्रदेश भोज विश्वविद्यालय, भोपाल के प्रथम छः परिनियम के प्रारुप समिति के समक्ष प्रस्तुत हुए। समिति ने इन्हें आंशिक संशोधन के साथ स्वीकार किया। परिनियम क्रमांक—1 में कुलपित की सेवाशर्तों के उल्लेख में वेतन आदि के लिए मध्यप्रदेश के अन्य विश्वविद्यालयों के लिए क्रमांक—3—2(29) में स्वीकृत व्यवस्था रहेगी।

Madhya Pradesh Bhoj (Open) University Addendum to Statute No. 1

- (1) The Kulpati shall be a whole-time salaried officer of the University.
- (2) The Kulpati shall hold office for a term of four years and shall not be eligible for appointment for more than two terms:

Provided that he shall cease to hold office on attaining the age of 65;

Provided further that notwithstanding the expiry of his term he shall continue to hold office until his successor is appointed and enters upon his office but this period shall not in any case exceed one year.

- (3) The Kulpati shall be appointed by the Kuladhipati from out of a panel of not less than three persons recommended (the names being arranged in the alphabetical order) by a committee constituted under clause (4):
 - Provided that if the Kuladhipati does not approve any of the persons so recommended he may call for fresh recommendations.
- (4) The committee referred to in clause (2) shall consist of three members of whom one shall be nominated by the Kuladhipati (as in the present statutes of IGNOU) and two nominated by the Board of Management and the person nominated by the Kuladhipati shall be the Convenor of the committee:

Provided that no person who is an employee of the University or of any affiliated Centre or a member of any authority of the University shall be nominated on the committee.
