## MADHYA PRADESH BHOJ (OPEN) UNIVERSITY

## STATUE NO. 2 Powers of Kulpati

(Refer Section 9 (2 To 5)

In addition to the powers and duties prescribed in the Madhya Pradesh Bhoj Vishwavidayala Act' 1991(No.20 1991). Kulpati shall also exercise such other powers and perform such other function as given below: -

- 1. The Kulpati shall be ex-officio chairman of the Academic Council, Planning board and Finance- committee and all Bodies of the University. The Kulpati shall be entitled to be present at end address any University but shall not entitled to vote there at unless he is a member of such authority or body.
- 2. It shall be duty of the Kulpati to see that this act and the statutes and ordinances and regulation made thereunder are duly observed and he shall have all the powers necessary to ensure observance. The Kulpati may constitute such committee as he deems it necessary to help him in the discharge of the duties entrusted to him or under the Act.
- 3. The Kulpati shall exercise control over the affairs of the University and shall give effect to the decisions of all authorities of the University.
- 4. The Kulpati shall have the powers necessary for the proper maintenance of discipline in the University and he may delegate any such powers to such persons, as he may deem fit.
- 5. The Kulpati shall be empowered to grant leave to any officer of the university in accordance with the rules and make necessary arrangement for the discharge of the functions of such officer during his absence.
- 6. The Kulpati shall grant leave of absence to any employee of the University in accordance with the rules and if he so desire, delegate such powers to another officer of the University.
- 7. The Kulpati shall have the power to convene the meetings of the Bodies of the University.
- 8. The Kulpati shall have the power to appoint on the approved and vacant post of professors, readers, lectures, and other teachers following the procedure of their appointment and with the approval of the Kulpati .
- 9. The Kulpati shall have the power to appoint court writer, script writers, counselors, programmes, artists and such other persons as may be considered necessary by the academic council for the functioning of the University with the approval of the Board of Management.
- 10. The Kulpati shall have the power to make short term appointments for a period not exceeding six months at a time of such persons as may be considered necessary for the functioning or the university with the approval of the Board of Management.

- 11. The Kulpati shall have the power to arrange for the establishment and maintenance of regional and study centers at different places as may be required from time to time and delegate to any employee such powers as are necessary for their efficient functioning.
- 12. If, in the opinion of the Kulpati any emergency has arisen which requires immediate action to be taken, the Kulpati shall take such actions as he deems necessary. Actions to such officer, authority, committee or other body as would have in the ordinary course deal with the matter, provided that the action taken by the Kulpati shall not commit the university to any recurring expenditure for a period of more than three months. Provided further that any action taken under this statute shall be reported to the Board of Management at its meeting immediately following such action.
